STATEMENT OF INTENT

In 1997, the New Hampshire General Court passed HB 436 that allowed the establishment of a special village district for the towns of Hebron and Bridgewater to construct, own, and maintain a public school facility with three elected commissioners to oversee the school facility and grounds. The village district then constructed and continues to own, debt free, the Bridgewater-Hebron Village school building, surrounding athletic fields and furnishings. It leases the school to the Newfound Area School District for \$1.00 per year. Teachers, staff, and curriculum management are provided by the Newfound Area School District. This bill is designed to expand Bridgewater's and Hebron's legal status as a village district, and explore, over a 4-year period, the establishment of a three-town special purpose school district. This is a VERY unique situation as Bridgewater and Hebron is the ONLY village district that owns its own school, but is not a school district. The goal of this bill is to reconfigure and structure the village district as a K-8 school district. Currently, the village school's education performance is outstanding and ranked among the top K-5 schools in the state. The current student count of Bridgewater, Hebron, and Groton accounts for about 15% of the Newfound Area School District student body and the corresponding budget contribution is roughly 16%. It is estimated that the reduction in middle school expenses coupled with SAU 4 gains in tuition and administrative revenue by the special village district also becoming a school district would result in little to NO fiscal impact to SAU 4. It should also be noted that Bridgewater, Hebron, and Groton are located on the extreme northwest corner of the Newfound Area School District. This results in students having to ride on a school bus 2.5 hours per day, an excessively long daily bus journey. This bill will rectify that situation. The firm of Wadleigh, Starr, and Peters (Manchester Attorneys of Law) have stated that this bill applies to a local situation where a separate municipality owns the building in which the children are educated; it is not capable of repetition elsewhere in the state and represents a truly unique set of facts. Lastly, in a letter received by the Education Committee from Virginia Berry (former Commissioner of NH Department of Education, 2009-2017) states that she STRONGLY supports the establishment of a special-purpose school district as proposed by the towns of Bridgewater, Hebron, and Groton.

Hello,

First of all, thank you for taking the time out of your busy schedules to hear us out on House Bill 349. My name is Sara Smith, I am a Groton Resident, I work for the Town of Groton and I am a parent of a child that attended Bridgewater-Hebron Village School (BHVS), Newfound Memorial Middle School, Newfound Regional High School and graduated from there in 2022.

I am here to fully support House Bill 349 for many reasons.

One of the main reasons is that it will provide our students with a better education if they have a K-8 model. K-8 models have been proven to be beneficial and have many advantages. Currently, our students leave the Bridgewater Hebron Village School after 5th grade and attend Newfound Memorial Middle School from 6th-8th grade. A K-8 model would allow them to stay where they are comfortable for a few more years. The age that they attend middle school is an awkward time for these kids. Physically, mentally and emotionally they are going through so many changes and not having to change schools on top of that would be extremely beneficial. When they leave Bridgewater-Hebron Village School they are going from being the older students at the school to the younger students at the middle school. This can be very tough on all kids and can lead to grades declining, attitudes declining and other negative affects while they are in middle school. This is a difficult time for students when they are going through many hormonal changes, body changes, etc. and changing of schools could be avoided at this time making things easier on them and allowing their academics to not be negatively affected.

I have done some research and one of the advantages I found is that "Students in K-8 schools thrive in the vibrant sense of community, develop important leadership skills and perform better academically than those who attend traditional K-5 and 6-8 environments." This is a huge reason why I support this bill.

The reason I just discussed is a positive reason for all students. Now I want to discuss a reason for our Groton students. We live in a rural community and Bridgewater Hebron Village School is closer to our town then the Middle School and High School is. When going to the middle school, our students in grades 6-8 are on the bus for about an hour and when going to the high school it is even longer, over an hour. This is too long for kids age K-8 to be on a bus knowing they get antsy. This can cause students to lose their patience and get distracted and act up when they normally wouldn't. This is caused from boredom or more time on the bus with older students. If these students were at BHVS from K-8 this would eliminate that extra time on the bus. Then when they are older and going to the high school, they will be on the bus longer when they will be able to handle it better.

Now speaking as a parent, I no longer have children in school but I am still advocating for all of the other children. We had an amazing experience at Bridgewater Hebron Village School and I wish the K-8 model was in effect when my son was in school. I know him and his friends would have benefited from this for the reasons I have listed above and for the many reasons you have heard and will continue to hear today from the other supporters.

I know there are many other people here to speak so I don't want to take more of your time with the chance of being repetitive but I will leave you today strongly urging you to pass this bill so that our students can receive the better education that they deserve.


Dear House Education Committee,



We liked that school district for elementary school but had some concerns because the upper grade levels were experiencing difficulties receiving accreditation.

As a parent wanting my child to receive the best education he can, this was a huge concern for me. Life happened and we found ourselves living in Groton and I transferred Caleb out of his current elementary school to Bridgewater Hebron Village School. As with any transfer we had concerns. Concerns about the education he would receive, how the teachers would be, making new friends and feeling supported.

It didn't take long at Bridgewater Hebron Village School to relieve us of these concerns, especially the concern about him receiving the best education he can. This is where Caleb received the best education, where he felt most comfortable, where he made some of his best friends and felt the most supported by our incredible teachers and staff.

One of the main reasons I support this bill is that, as I did with Caleb, I want all students to receive a better education. I feel Caleb would have benefited even more from staying at Bridgewater Hebron Village School longer. K-8 models have been proven to be beneficial and have many advantages. Currently, our students leave the Bridgewater Hebron Village School after 5th grade and attend the Middle School from 6th-8th grade. A K-8 model would eliminate the transition and allow them to stay where they are comfortable for a few more years. The age that they attend middle school is an awkward time for these kids. Physically, mentally and emotionally they are going through so many changes.

When they leave Bridgewater-Hebron Village School they are transitioning from being the older students at the school to the younger students at the middle school. All of this can be very tough on all kids and can lead to challenges while they are in middle school.


We live in a rural community and Bridgewater Hebron Village School is closer to our town then the Middle School and High School is. Our Groton students are on the bus for about an hour to the middle school and longer to the High School. This is too long for kids age K-8 to be on a bus. Creating K-8 this would eliminate that extra time on the bus. Then when they are older and going to the high school, they will be able to better handle the longer ride.

Caleb would have benefited from being able to choose which High School he attended. There are high schools that are closer to Groton. In high school, our kids get their licenses which is a very scary time for parents. Where we live, the weather is also a concern. If we were able to choose the high school he attended, we would have been able to choose one that was closer with less travel time for him, spending less gas money, and less time worrying during bad weather. Caleb doesn't play sports but he jumped into the work force quickly. He would travel from school to work each day. If he could have chosen a high school close to where he works, it would have been more convenient and saved money on travel.

I no longer have children in school but I am still advocating for all of the other children. We had an amazing experience at Bridgewater Hebron Village School and I wish the K-8 model was in effect when Caleb was in school.

Thank you for listening and I respectfully urge you to pass this bill so that all of our students can receive the best education they deserve.

Testimony – Terry Murphy

INTRODUCTION

Good morning, Mr. Chairman and Committee Members.

My name is Terry Murphy and I enthusiastically support HB349 bill. Supporting me in this process is Selectmen Maurice Jenness and Wesley Morrill

I'm a Select Board member from the town of Bridgewater serving since 1977. I'm also a Commissioner on the Bridgewater-Hebron Village District Commission since its inception in 1999..

I was a faculty member of Plymouth State University for 45 years and, in its outreach programs over 10 years, assisting the Pemi-Baker School District for its financial and student management systems. In full disclosure, my spouse is Virginia Barry, the former NH Commissioner of Education.

BACKGROUND

The Bridgewater-Hebron Village District is a separate political subdivision created by statute in 1997 and is comprised of the Towns of Bridgewater and Hebron. This statute authorized both Towns to build and operate the Bridgewater-Hebron Village School (B-HVS). Three elected Commissioners oversee the school facility and grounds.

The Village District continues to own, debt-free, the Bridgewater-Hebron Village School building, surrounding athletic fields, and furnishings. [PHOTO] It leases the school to the Newfound Area School District (for \$1.00 per year. Teachers, staff, and curriculum management are provided by the Newfound Area School District.

The school was built to alleviate overcrowding in SAU4 at a multimillion-dollar cost to the taxpayers of Bridgewater and Hebron in 1999. Since then, Bridgewater and Hebron are responsible for **maintenance**, **repair**, **and capital improvements**. Bridgewater and Hebron students have been a minority among students enrolled in the school. Children from other towns have always been welcome to attend.

VISION AND GOAL

This bill is designed to expand on our legal status as a Village District and explore, over a four-year period, the establishment of a three-town special purpose school

district. This is a multi-step process and the first step is to hold a vote in Bridgewater, Hebron, and Groton to determine if our citizens want to establish a K-8 SAU.

Our vision is to improve education outcomes for our children with an innovative alternative to a traditional middle school. Our goal is to reconfigure the Village School to a K-8. Studies have shown the fewer number of transitions children make before High School the greater the improved student performance. In fact, all seven towns in Pemi-Baker's SAU48 use the K-8 model.

Hill, NH also formed a separate School District after withdrawing from the Franklin School District. They operate their own elementary school and tuition into the Newfound Area School District for grades 7-12.

EXPANDING OUR SUCCESSFUL EDUCATION MODEL

The Bridgewater-Hebron Village School's education performance and is consistently performing in the top 20th percentile in the State for Math and English. Reconfiguring to a K-8 allows us to continue our proven high academic standards with a coherent curriculum, effective instruction, strong leadership, results-based accountability, and sound discipline through the 8th grade. It would allow more effective local control, better manage educational costs, and give parents an innovative alternative to traditional middle school.

WHY NOW?

Today parents are becoming more engaged in educational outcomes for their children. There's a growing trend toward alternative education options. And in our local case, a trend toward the public K-8 model. Given this climate, the bill gives us the authority and the time to thoughtfully think this through.

WAY AHEAD

We would seek to stay closely aligned and work cooperatively with the Newfound Area School District to support quality education for our children. We would support space-based reciprocal enrollment for grades K through 8. By inviting students from other towns to attend, we would offer parents a choice between a traditional middle school and a K-8 program. We would seek a cooperative relationship.

This bill gives us an option to create our own district and reconfigure to a K-8. We have 4 years to research and determine if this is the best choice for our towns and our children before the authority in the bill expires. In the end, our voters will decide.

HB 349 provides a narrow, singular fix that would re-align us with the state's public education model. This bill is a turnkey solution. And our final education plan must be approved by the Board of Education.

Finally, we as citizens have a responsibility to provide for our children's public education. This bill provides that opportunity.

Thank you for the opportunity to speak in support of House Bill 349. My name is Derry Riddle. I'm a resident of Hebron. I've been an elected commissioner of the Bridgewater-Hebron Village District since its inception about 25 years ago, where I've had the privilege of being part of the construction and management of the facility of our local Bridgewater-Hebron Village School. I was the first president of the parent teacher community organization and have volunteered in various capacities at this school plus others throughout the Newfound Area School District. One of my sons attended the Bridgewater-Hebron school and recently my grandsons have been students there, where they've thrived in a nurturing atmosphere supported by caring teachers, staff, parents, and community members. I've been on numerous committees addressing public kindergarten, technology, the vision and mission of the school district, the greenhouse at our school, and the building and facilities needs of the Newfound Area schools.

With your support of House Bill 349, we have a unique and exciting opportunity to create a positive K-8 learning environment for our local students.

Mr. Chairman, May I please use my remaining time to read into the record a letter from the former NH Education Commissioner, Virginia Barry, who was unable to attend today?

Dear Chairman Ladd,

I strongly support the establishment of a special-purpose school district as proposed by the towns of Bridgewater, Hebron, and Groton. As the former Commissioner of Education for the State of New Hampshire (2009-2017), I had the pleasure of visiting many excellent schools in our state. The State of New Hampshire has much to be proud of with its continued ranking in the nation's top five states for educational success. As Commissioner, I was often asked to explain our success to the public. Of course, we have many outstanding teachers and leaders committed to our children, families, and communities. However, there is another critical factor in our state's national achievements. The movement of school choice options available to nearly 320,000 children through bi-partisan leadership has helped define our state as one that supports parent choice. New Hampshire currently is one of the only states that support traditional public schools, public charter schools, public magnet schools, private schools, online academies, and homeschooling. All these choices are available to families to choose what is in the best interest of their child's needs, family values, and sustainable communities.

New Hampshire places great value on our small towns and their role in the stability critical to the economic health of our state. Citizens of New Hampshire have a voice, whether it's water quality, access to nature, housing choices, transportation, and many other components of infrastructure. Our residents know that our governmental structure cares what they have to say. The heart of our great state remains focused on our communities and their needs, including recognizing that times have changed. Our small towns' safety, vibrancy, and sustainability should remain a commitment in our governing structure. Recognition of the changing times refers to helping towns meet the community's educational, health, and safety needs. The towns of Bridgewater, Hebron, and Groton have demonstrated their deep devotion to quality education and the desire to have a school that reflects an understanding of the importance of family values in their schools. A sense of pride and conservation of small-town togetherness in daily life. The school these community members envision is another example of choice in our state, with a serious commitment to a "sense" of the future and everyday safety and fellowship so needed in our society.

This perseverance is especially evident when in 1999, the communities of Bridgewater and Hebron joined to construct a modern school building open to all towns in the Newfound Area School District. The building was separate from their existing cooperative school district obligations, and since 2000 the towns leased the facility to the school district for \$1.00 per year. The maintenance and building upgrade costs are the sole responsibilities of the Bridgewater-Hebron Village District. Concurrently, the facility is open to many local agencies for community activities to support extracurricular sports and boys' and girls' community clubs. The school

presently houses a Pre-K, full-day kindergarten program, and first through fifth grades. Children from other towns in the cooperative school district currently constitute 55% of the Bridgewater-Hebron school enrollment. The proposed legislation will not impact other community's enrollment if the K-8 expansion is approved. Fiscal constraints in the SAU4 prevent the adoption of this enhanced program configuration.

Recent research focusing on Pre-K and K-8 school configuration has continued to grow, focusing on the importance of children's social-emotional (SEL) needs in our current society. Intuitive leaders in our state might consider looking at the multiple benefits for K-8 students in the same school setting. The benefits include improved student social-emotional skills, positive attitudes about self and others, connection to school and town, academic performance, and reduced conduct problems and emotional distress. It's hard to imagine the minds of children when bombarded with social media focused on violence every day throughout our country. A school with community support and a belief that citizens "own" the school with an intense commitment to success and a healthy mindset is the best we can offer our children.

The proposal seeks to promote a community K-8 school to enhance learning and social-emotional competence based on the three towns' choices to support these critical years of development. The K-8 structure provides a positive learning environment that promotes trust, initiative, and autonomy. A K-8 school program has proven to improve academic performance and greater community involvement when parent choice is acknowledged.

In closing, this proposal supports the spirit of New Hampshire's history, encouraging choice, community connectedness, and success for all citizens. I urge the House Education Committee to consider this forward-thinking proposal. The potential outcomes of success for the students and recognition of the people's desire to protect and educate their children only strengthen our state.

Thank you for this opportunity to share my thoughts on this worthy proposal. Despite the challenges facing our nation, I believe that New Hampshire will continue to lead the country in educational success and promote and safeguard our children and communities.

My name is John Rescigno, I'm the Chair of the Selectboard for the town of Groton. I'm here to speak enthusiastically in support of this bill.

With me is my fellow Selectman Tony Albert. Together we represent and serve 569 Groton citizens.

Groton is a small, tight-knit rural community spanning over 40 square miles at the extreme northern end of the 7-Town, Newfound Area School District.

We have 48 students enrolled in the Newfound Area School District's K-12 system.

TESTIMONY IN SUPPORT OF HOUSE BILL 349 February 10, 2023

Honorable members of the committee and fellow-citizens, thank you for this opportunity to submit my testimony today. My name is Thomas Curren, I am a resident of Bridgewater, New Hampshire, and I wish to testify enthusiastically in support of House Bill 349, an act to support a special purpose school district for Bridgewater, Hebron, and Groton. In 1972 I began working as a guidance professional assigned by the Dartmouth-Hitchcock Mental Health Center to work in the Mascoma School District, and then went on to be the Family Treatment Specialist at Spaulding Youth Center in Tilton. In those roles, I worked extensively in schools and homes with parents of special needs children. Later was appointed as vice-president of the Crotched Mountain Foundation, where my responsibilities included both admissions and discharge planning for students and their families in scores of districts throughout the state and region. I held that position for 8 years, after which I was asked to join the board of trustees of the organization. I have lived in the Newfound District since 1975, and my daughter graduated from Newfound Regional High School. In the late 1990s, I was elected to serve as a member of the Bridgewater Board of Selectmen that worked to create, gain approval for, and fund the Hebron-Bridgewater Village School District.

My support of HB 349 stems from my experience as a parent, an educator, a selectman, and most recently as a town moderator. As an education professional, I became aware of a number of difficulties confronting children throughout the state. The first were the challenges involved in unreasonably lengthy commutes that came to be measured in hours spent by children in busses. Additionally, as a parent, from a developmental standpoint I was concerned about exposing elementary aged children to troubling teenage social and behavioral patterns, the sort of burdensome dynamics that our youngsters are ill-prepared to handle. Finally, as an elected official, I have heard repeated expressions of frustration on the part of citizens who feel a lack of connection with far flung school districts. When I wrote the town history of Bridgewater in 1987, old-timers spoke of the deep sense of loss that occurred when local children were removed from their neighborhoods.

In my estimation, a basic duty of rural education is to assure that the legitimate organizational needs of large districts do not override the core mission of providing a nurturing love of learning in children at a local, human level. It was for that reason, including the prospect of increased volunteer involvement in a local school, that we put forth the effort to create the Hebron-Bridgewater Village District more than two decades ago.

The results in the ensuing years have proven out the hoped-for strengths of this local, logical approach. Children, parents, and educators have consistently expressed their satisfaction and their pride in this model, and test scores have borne this out over the years. Focusing developmentally on the needs of younger children is a major strength of the K-6th elementary model. The Village District is a sensible, tradition-based innovation that we feel has amply earned the support of this enabling legislation. Thank you for your consideration.

Re: House Bill 349: An Act Relative to a Special Purpose School District for Bridgewater, Hebron, and Groton

Dear Mr. Murphy:

You asked us to review House Bill 349: An Act Relative to a Special Purpose School District for Bridgewater, Hebron, and Groton. In particular, you have asked us to opine whether the Bill constitutes a lawful act of the legislature. In our opinion, the answer is yes. We reach that opinion for the following reasons:

1. The legislature retains authority over the formation of public school districts.

New Hampshire is not a home rule state. [N.H. Rev. Stat. Ann. § 49-B:1; Harriman v. City of Lebanon, 122 N.H. 477, 481 (1982).] Moreover, while school districts are a separate corporate entity, they serve as a subdivision of the state. ["School districts, like counties and towns, are political subdivisions of the state made for the convenient administration of the government." Clough v. Osgood, 87 N.H. 444, 182 A. 169, 171 (1935), N.H. Rev. Stat. Ann. § 194:1..] As a result, the legislature has exercised its authority over the span of its history to create school districts through enabling legislation. In the past 30 years, the legislature has self-regulated that authority to create and establish school districts by voluntarily subordinating its authority to local control. In other words, the legislature has passed enabling legislation, but has made the adoption of such subject to the will of the citizens in the local towns, cities, or school districts. For example, recently the legislature adopted a Bill with regard to the Manchester School

District authorizing certain charter amendments and the establishment of further independence on the part of the School District. However, that legislation was contingent upon adoption by the local legislative body.

This Bill follows that model and if passed is a lawful exercise of the General Court's legislative authority, but with due deference to the local decision of the voters.

2. The Bill repairs a unique flaw in the cooperative withdrawal statutes.

In this case, the Bridgewater-Hebron Village District owns the school attended by the students in the Bridgewater-Hebron-Groton area. This is a truly unique fact which deviates substantially from the norm. The adoption of this Bill provides a pathway for the Bridgewater-Hebron-Groton towns to normalize the relationship with the Village District and create their own district which more aligns with the fact that the ownership of the building in which the children are educated reposes within the local municipality.

The general court is well aware of the challenges presented by the withdrawal provisions of cooperative school districts. While one can argue on either side of the issue in regard to the correct manner in which to approach withdrawal, on these facts, there is little or no doubt that the local act of the legislature will provide an opportunity to cure a model which deviates from the norm.

3. As a local act, this Bill does not modify the general provisions pertaining to other cooperative school districts.

At first blush, there may be reluctance on the part of some to adopt this Bill due to the fact that it creates a more nuanced withdrawal process. However, this Bill applies to a local situation where a separate municipality owns the building in which the children are educated, it is not capable of repetition and represents a truly unique set of facts.

For the reasons set forth above, it is our opinion that this local legislation is consistent

with the legislature's authority.

Frequently Asked Questions about Hb349

1- What does this bill do?

This Bill authorizes the Towns of Bridgewater, Hebron and Groton to vote whether to form a special K through 12 school district. It addresses the unique circumstances arising from the fact that the elementary students from Bridgewater, Hebron and Groton are already educated in a school owned by the Bridgewater-Hebron Village District. This bill does not create a new school district, but instead allows the citizens to vote to create a school district. Upon an affirmative vote by the three towns, they will be withdrawn from the Newfound Area School District and the SAU and as of the established operating date, they will become a separate school district.

2- How does creation of the new school district take place?

The bill gives the three towns up to four (4) years in which to study and plan for the potential creation of a new school district known as the Bridgewater-Hebron-Groton Special Purpose School District.

The Select Boards are authorized to appoint committees and to study and plan for the creation of the new district prior to bringing the matter to a vote. Upon a majority vote, and operating date shall be set for the new district. At a subsequent annual meeting the citizens will then adopt an operating budget, elect district officers and a school board. The District will commence to function as of its effective date of operation.

3- How will children be educated?

Elementary age child will continue to be educated in their local elementary school. Middle and high school children will be educated pursuant to negotiated tuition agreements, either with the Newfound Area School District or another School District, such as the Plymouth School District. In addition, the new district will have the prerogative to expand its facility to add middle school at the local village district school.

4. What are the benefits of the creation of this new school district?

The creation of this new school district will benefit the towns of Bridgewater, Hebron and Groton by providing local control over education. It will also relieve the towns and their taxpayers of the continued risk of inequitable apportionment of District operating costs. The new school district also presents revenue opportunities to the Newfound Area School District. If Newfound is willing to enter into a fair tuition agreement, it will have the benefit of a revenue stream that will allow it to move forward with its desired capital projects.

5. What Problems does this bill solve?

This bill ensures that elementary and potentially middle school education is both local and locally controlled. It allows for a greater local focus on educational quality.

By right-sizing the two resulting school districts in allows for an equitable apportionment of district operating costs in both districts. It potentially will strengthen the Newfound Area School District by allowing for tuition revenue as a potential offset to taxes incurred by the remaining towns.

6. Does this bill mean that we are withdrawn from the Newfound Area School District?

No. This bill authorizes a unique opportunity for the three towns to vote to create a school district. This is truly unique due to the fact that two of the three towns share a village district that owns the elementary school building. Whether or not the three towns decide to create the Bridgewater-Hebron-Groton Special Purpose School District will require a majority vote in each of the three towns to create the school district.

7. Won't this bill require that we hire new administrators?

Not necessarily. Other school districts have successfully negotiated contracts with a neighboring SAU to provide superintendent services, and that is an option for the new school district. There is a significant likelihood that the cost of these services will be equal to or less than the current portion that the three towns pay toward the SAU budget.

8. Will this bill be detrimental to the Newfound Area School District?

No. In this case, the infrastructure for providing local elementary education is already in place, and that operational cost will be shifted from Newfound to the new district which will benefit from that infrastructure. If anything, the bill will generate new revenue for the remaining district by way of tuition agreements, while enhancing more local control for the Newfound Area School District as well.

9. Is this bill detrimental to other cooperative school districts?

No. This bill deals with a very unique set of facts where the students who comprise the District will be educated in a school that is already owned by two of the three towns through the Bridgewater-Hebron Village District. No other towns in New Hampshire have such a situation, and this bill does not apply to any other cooperative school district.

Mr. Chairman, Members of the Committee:

My name is Patrick Moriarty. I've been Member of the Hebron Select Board for 10 years. I am here along with our other Select Board members Rich James and Paul Hazelton to represent the Town of Hebron in support of this bill

I grew up in a low income household as my Dad was a POW and disabled veteran

I lived in public housing and attended public schools. I am a strong advocate for public schools and consider that the education provided is critical to success of the students and to our state and nation.

My public education lead me to a scholarship to Northeastern University, where I graduated with honors. After my military service I completed a Master's Degree at Babson College.

For the past twenty years I have been a trustee for the Mayhew Program, an important non-profit serving disadvantaged youth in our state. I am now the Treasurer so work daily on youth development in our state.

The people of Hebron are aware of this proposed legislation and are in favor. The people of Bridgewater and Hebron paid for the school and maintain it on an annual basis. They take great pride in the school as an important part of our community. The school is our emergency shelter, our police protect it and visit for safety checks and run the bike safety programs. We alone provide these services as well as excellent athletic fields, without any outside financial support. The towns' people understand this proposal to establish our own school district and reconfigure to a K-8 model will require additional cost. And we fully intend to form a cooperative relationship with SAU 4 for high school, sports and activities.

Our goal is only to improve public education for our children, have more local control

Our current school district, SAU4, covers close to 300 square miles over seven towns making it difficult to manage, move children, and balance classroom size.

The far side of Groton is more than an hour drive from the other schools. Our three towns included here lie north and border Plymouth and Dorchester/Rumney.

The Plymouth school district runs fully on the K to 8 model for these reasons of time and distance.

The other four towns in SAU 4 lie west to east along state route 104, from Danbury to New Hampton. This is a convenient break for consolidation of classes in one main elementary school....now under study by the District.

Finally, our goal is to improve education outcomes for our children. This bill allows for greater local focus on education quality, and by establishing our own three town school district and reconfiguring to a K-8 it allows parent a choice between a traditional middle school and a K-8 program.

I hope you will vote in favor of this important legislation.

Testimony in support of HB 349 Jennifer Larochelle, educator Friday, February 10, 2023

Honorable members of the committee thank you for listening to testimony today. My name is Jennifer Larochelle, and I am here to testify in support of House Bill 349. I graduated from the University of New Hampshire with a BA in Psychology followed by a Masters in Reading and Writing. I also have my Certificate of Advanced Graduate Study from New England College in Educational Leadership and taught for 25 years teaching in the Newfound Area School District. I am a resident of Hebron, and my son, Alex, attended the Bridgewater-Hebron Village School.

I am here today to speak for children and families. In my years in the classroom, I have seen tremendous changes in children, families, and society. The impact that comes with those changes has affected our children in ways that are sometimes visible and sometimes hidden. Even prior to the Pandemic, our children were struggling. The CDC reports from 2016-2020, 5.8 million students diagnosed with anxiety, and 2.7 million diagnosed with depression. Research suggests that the K-8 model is helping to combat the struggles our children face. Passage of House Bill 349 is critical to our vision for our children.

Sixth grade students are at a vulnerable time in their development. Think back, acne, awkwardness, hormones. Switching schools at this fragile time creates increased stress and anxiety at the best of times. As part of past transition teams, I can assure you that those students really do think they are going to be stuffed in lockers by older students. The K-8 model offers no such transition. Instead, children remain in a nurturing, familiar environment where they can continue to grow both academically and socially.

"Oh, you're a teacher. What do you teach? Middle School, you're a saint!" I have heard this too many times to count. Middle school doesn't have a great reputation. This reputation keeps a lot of parents away. The drop in parent involvement in education is dramatic when students enter middle school. Parents are an important part of their child's education. Purdue University writes, "A consistent body of research concludes that parents are the first and foremost influence on their children's development and school success. When parents are involved, students get better grades and score higher on standardized tests. What's more, children of involved parents have better attendance records, drop out less often, have higher aspirations, and more positive attitudes toward school and homework."

Fewer transitions for students and continued parental involvement indicate to me that the K-8 model is not only good for our children, but it is good for our families. That same familiar, nurturing environment that supports our students also supports our families. The Bridgewater Hebron School has a 20+ year history of providing strong educational opportunities for students and strong parental involvement. House Bill 349 grants us the opportunity to continue that tradition for our community and our families through 8th grade. I ask that you to help us guide our students by supporting this bill. Thank you.

AMENDED ANALYSIS

This bill:

- I. Establishes restrictions in building aid for conversions of area schools to cooperative school districts.
- II. Provides that an increase or decrease in grades being offered by a cooperative school district may be accomplished by amending its arrangement or articles of agreement.
- III. Allows the establishment of a special village district for the towns of Hebron and Bridgewater to construct, own, and maintain a public school facility.
- IV. Authorizes the Exeter school district to create special funds to be used to offset taxpayers' share of the Exeter region cooperative school district's bond payments for a new middle level cooperative school building and the capital improvements to the Exeter region cooperative school district buildings. The bill ratifies votes taken at the 1997 Exeter school district meeting to establish and make appropriations to these funds and authorizes additional appropriations to, and withdrawals from, these funds.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Establishment of Special Purpose School District.

I. Having established by law in 1997 a special purpose village district to construct, own and maintain a public school facility; and having already built and owned outright with no debt the Bridgewater-Hebron Village School (K-5) whose maintenance and capital costs are paid for by the towns of Bridgewater and Hebron and overseen by 3 elected commissioners; and notwithstanding any other provision of law to the contrary, the towns of Bridgewater, Hebron, and Groton are hereby authorized to withdraw from the Newfound Area School District and establish a public school district comprised of the geographical limits of the aforementioned 3 towns. formation, the school district shall operate in accordance with the provisions contained in RSA 194 and except as modified herein, the laws pertaining to operating a newly formed cooperative school district as set forth in RSA 195 and operating school administrative units as set forth in RSA 194-C. The new district shall be named the Bridgewater-Hebron-Groton Special Purpose School District, or such other name as is subsequently approved by the elected school board of the district. The creation of this new public school district shall be contingent upon a majority vote in each of the 3 towns at their 2023 annual meeting, or such other annual meeting as is determined by the 3 towns under this act, adopting the provisions of this act; whereupon the effective operational date of this district shall be the first of July of the fiscal year subsequent to the adoption vote unless the annual meeting specifies a later fiscal year to be the effective operational date.

II. The state board of education shall issue a certificate of withdrawal from the Newfound Area School District after the initial vote by the towns to adopt the provisions of this act. A special meeting of the voters in the withdrawing district for the election of board members and officers shall be held at a time set by the state board of education after consultation with the selectmen of the 3 towns. The warrant for this special meeting shall be proposed by the selectmen of the 3 towns, approved by the state board of education and signed by the commissioner of the department of education, shall provide for the election of officers in the newly created school district. The commissioner of education shall have authority to appoint such officers pro tem as may be necessary pending the district special meeting held to elect officers. In addition, the special meeting shall have the same power and authority as an annual meeting to raise and appropriate money, but it may defer the process of adopting a budget for the first operational fiscal year until the next annual meeting or such annual meeting as may be appropriate for adoption of a budget for the first operational fiscal year. The school district officers elected at said meeting shall take office and

organize promptly such that they carry out the duties of their office and take any action necessary to carry out the provisions of this law. The initial board shall consist of 3 elected members, with one member from the town of Bridgewater, one member from the town of Hebron, one member from the town of Groton.. The initial term of the member from Bridgewater shall be for a 2-year term, with the other initial members and all subsequent members serving 3-year terms.

III. The elected school board for the Bridgewater-Hebron-Groton Special Purpose School District shall have the responsibility and authority granted to a school board of a cooperative school district. It shall have the responsibility to effectuate plans and policies for the ensuing operation of the district, hold the necessary budgetary hearings and if not adopted at the special meeting, propose the initial operating budget to the legislative body of the created district at an annual meeting of the district to be held in the same manner as an operating school district under RSA 195, RSA 197 and RSA 198 for adoption of an operating budget for the fiscal year commencing on the effective date of operation. This annual meeting shall have the same power and authority as the annual meeting of a fully operating school district including, but not limited to the raising or appropriating money for the ensuing fiscal year.

IV. The school district may rent or lease a facility from the Bridgewater-Hebron Village District and notwithstanding any law to the contrary, may, subject to any state design, safety, and space requirements, vote to expand the grades served by a school within the district up to twelfth grade. The Bridgewater-Hebron Village District shall give priority in any lease or rental agreement to the students within the Bridgewater-Hebron-Groton Special Purpose School District. The school district may educate students in grades 9 and above outside the district pursuant to tuition agreements. The school district may make all other contracts necessary to carry out the purposes of a public school district, and may exercise any other power conferred upon single school districts under RSA 194:2, RSA 194:3 and any other applicable laws. The department of education shall work collaboratively with the new district to ensure that grant funds and adequacy aid are properly allocated to the Bridgewater-Hebron-Groton Special Purpose School District.

V. On and after its establishment, the Bridgewater-Hebron-Groton Special Purpose School District shall be deemed to be a duly organized school district for purposes of its eligibility to apply for and receive all forms of aid, grants, and guarantees with respect to the school building including, but not limited to, school building aid under RSA 198 and the state guarantee of bonds or notes under RSA 195-C. The amount of school building aid shall be based on the calculations applicable to a cooperative school district comprised of the 3 towns. The operating costs and any capital outlay costs for the district shall be apportioned between the 3 towns in accordance with the following formula:

(a) One hundred percent of all such costs shall be apportioned on the basis of the average daily membership from each town for the preceding year; or

(b) Such other formula as is recommended and proposed by the school, adopted by majority vote of the district meeting and approved by the state board of education.

VI. This act shall be construed to authorize such school district to staff and operate such school district, to otherwise provide public education to any pupil, to exercise any other power reserved to school districts. The district is granted such powers as are expressly stated in this act or necessary by implication to effectuate the purposes authorized by this section. In addition, the Bridgewater-Hebron-Groton Special Purpose School District shall seek to offer employment opportunities to the existing public school staff and faculty in the same manner as the pre-existing district. Further, the Bridgewater-Hebron-Groton Special Purpose School District shall work closely with the Newfound Area School District to endeavor to continue its relationship as put forth in the existing contract between the Bridgewater-Hebron Village District and former district to offer parents school choice and to accommodate students already enrolled in the new district's school.

VII. Upon the adoption of this act by the 3 towns, the towns in the Bridgewater-Hebron-Groton Special Purpose School District shall be deemed to have effectuated withdrawal from the Newfound Area School District on July 1 of the calendar year one year subsequent to the date of the vote adopting this act unless the meeting specifies a later fiscal year to be effective operational date, subject to any obligations set forth in RSA 195:27. The newly formed school board may enter into long and short-term tuition agreements with the Newfound Area School District or any other public school district, public academy or school pursuant to RSA 193:3, VI for the education of those resident students in middle or high school who enroll in the Bridgewater-Hebron-Groton Special Purpose School District and may also vote to build additions or a separate school. The term of office of the Newfound Area School District board members representing Bridgewater, Hebron and Groton shall terminate as of the July 1 effective operating date of the newly formed school district.

VIII. Notwithstanding the provisions of RSA 195:30 and RSA 194-C:2, the newly formed district shall be deemed to have withdrawn from School Administrative Unit Number 4, as of the specified effective operational date of the Bridgewater-Hebron-Groton Special Purpose School District, and shall be its own school administrative unit with a number assigned by the department of education and may provide for superintendent services in accord with those options available to single school districts, including contracting for such services. The unassigned fund balance of the SAU shall be allocated between the two districts as of June 30 immediately prior to the July 1, operating date in accord with the apportionment percentages of the Newfound Area School District budget for the prior fiscal year. The newly formed district may enter into agreements with Newfound Area School District regarding the disposition of school administrative unit assets and liabilities.

IX. The select boards of the towns of Bridgewater, Hebron, and Groton may appoint such committees and engage in such study as they deem appropriate in planning for the new district prior to the adoption vote. However, if the select boards of the 3 towns wish to proceed further with this

- legislation they shall within 4 years from the effective date of this act, warn the question of adoption
